Associate memberships may be upgraded to Full Single or Household when the Associate Member(s) submits an application with the endorsement of two AWSC, Inc. members in good standing and the payment of the additional fee required.

Membership runs from January 1 to December 31 of each year. Must be returned by January 1, 2012
